

## **Newcomers Welcome Ministry**

The Newcomers Welcome Committee's mission is to identify new visitors to the church, greet them, introduce them to parishioners, and bring them into the community. Mother Liz extends to each newcomer an opportunity to meet with her. The Welcome Committee follows up with an additional communication to acquaint them further with St Thomas.



At coffee hour, there is a welcome table with information and the committee introduces them to parishioners as well as answers questions. Part of the Newcomer program is a series of events which include a newcomer recognition at coffee hour, Newcomer Party with Church Leadership and staff, and member recognition or reading of the names in church. An Episcopal 101 class will help those interested to learn more about the church.



This past year has been one of exceptional growth and vitality with newcomers in large part because of parishioners openly welcoming and taking the opportunity to share their experiences and enthusiasm about St Thomas. It appears our second year this growth is continuing. The entire leadership of St Thomas has been

exceptionally supportive of these efforts.

## Liturgical Guild

We have over 128 active volunteers who come together every Sunday to support our worship services at 8 and 10 a.m. They also provide assistance at special services during Advent, Lent and, Holy Week, and support families and visitors attending Celebrations of Life services.



Our greeters (led by Nancy and Peter Pitarys) welcome everyone as they enter our Sanctuary – keeping a special eye out for newcomers. Our ushers (led by Jerry Livingston) help coordinate traffic flow during the service, and are our first point of direction should there be an emergency. Youth acolytes (led by Bill McSherry) lead the procession into and out of the church carrying the cross and the torches. Our



intercessors and lectors (led by Kim Malcom) read the lessons and lead us in intercessory prayers. At the Altar, our MC's (led by Mark Nelson) assist the Clergy with preparation for the Eucharist and our Lay Eucharistic Ministers- LEMs (led by Valerie Wang) assist with the distribution of the bread and the wine during Communion. Our Coffee Hour hosts provide wonderful refreshments for us every Sunday. Behind the scenes we also have Godly Play volunteers who run concurrent programming during the service, giving younger children a chance to interact with Scripture in a more tactile way.

The Liturgical Ministry team (led by Tera Soelter and Bea Covington) supports these volunteers by providing

scheduling and coordinating annual training. We also have instruction manuals (also known as Customaries) that serve as handy references for each ministry.

We are grateful for the time and dedication of all these volunteers and welcome new members! We are also looking for new Leaders to help with coordinating these teams. 



#### **Adult Formation Committee**

We offered a variety of adult formation offerings in 2023. Most of the formation opportunities were offered on Sunday morning following the 8am and 10am service or on Wednesday evening. Offerings ranged from topic-based series on Science and Religion, Social Engagement Models, The Liturgy of Holy Week, The State of the Church in England, and more. During Lent we read the book, "Hanging by a Thread: Questions of the Cross," and brought in guest speaker, Grace Hamman who also led the Women's Retreat for Lent. The Legacy Society hosted a series, "Getting Your Ducks in a Row" that included one session on the theology of death and dying, led by Mother Liz.

For the 2023-2024 program year we are focusing on the Bible. To support this goal, we are reading *The Path* which goes over the biblical narrative over the course of the program year and brought in the St. John's Bible for Lent 2024.

A challenge we faced is growing our adult formation committee. If you would like to join, email Mother Liz! We also faced the challenge of discerning the best time to hold adult forums. In 2022-2023 we held adult forums at 9am. They were not consistently well attended. In 2023-2023 we made a change and decided to have a small group meet at 9am to read *The Path* and then host Adult Forums following the 10am service, at 11:15 am.

#### Music Guild

The mission of the St Thomas Music Guild is to enable the continuation of the great heritage of Anglican music including Anglican Evensong worship, and congregational worship music, along with programs of sacred music to the greater Eastside community. The goal is to serve

music lovers of all ages by providing a wide variety of musical styles, both vocal and instrumental that reflect the diversity of the community of which we are a part.

The Music Guild steering committee is in the strategic planning stage, establishing an organizational structure and specific, measurable goals that will move our mission forward. These goals will be both financial and artistic.

Paul Klemme, the Director of music ministries at St Paul's Episcopal Church in Salem Oregon, has met with the committee and offered valuable advice. St. Paul's has provided a very successful yearly community Evensong/concert series for over 20

years. It is a program that is supported by parishioners and non-parishioners alike.

Recent offerings like the Piano for Eight Hands, and Amahl and the Night Visitors demonstrate the potential to reach out beyond the walls of the church to offer the spiritual gift of music. We hope to pattern a music ministry that reflects the needs of St. Thomas as well as offer a music program the reaches out to the greater Eastside community.

#### **Pastoral Care Ministries**

Over the past year, the Pastoral Care Committee has been working with the clergy and staff to develop a continuum of pastoral care for St. Thomas Church, and four new lay-led ministries have been launched.

#### Lay Eucharistic Visitors (LEV's)

Lay Eucharistic visitors are lay persons authorized to take the Eucharist to parishioners, who because of infirmity or immobility, are unable to be present at

church. Ideally, a LEV is sent by the congregation after Sunday morning worship to take communion to the residence, but scheduling also considers the needs of the communicant. LEV's are trained and led by clergy; presently, six volunteers are licensed to serve in this ministry.

#### **Touchpoints**

Touchpoints volunteers keep in touch with parishioners unable to attend church because of temporary or long-term health or transportation issues. Offering a caring presence at a time of loneliness, illness or isolation through visits, phone calls and greeting cards, volunteers help maintain caring connections with the St. Thomas community. In-service support for volunteers is offered at monthly meetings. Currently, eight volunteers are serving in the Touchpoints ministry.



#### **Stephen Ministry**

The Stephen Ministry equips us *for building up the body of Christ*. Stephen Ministers are trained to offer confidential, one-on-one Christian care to people experiencing debilitating illness, bereavement, family crises or other life challenges. Although they are not counselors, Stephen Ministers are taught to recognize the need for referral for professional care. Training for a class of 10 begins this month and will be completed by June. Three former Stephen Ministry leaders are available to serve until training is concluded.

#### **Prayer Ministry**

Through the Prayer Ministry, Prayers of the People are regularly reviewed and updated so that prayers are offered on a timely basis. Calls at regular intervals to those on any of our four prayer lists are enabling St. Thomas to be responsive to those needing our prayers and pastoral care.

Grief and Loss and Caregivers support groups are being considered for later in the spring if needs are indicated.

#### Outreach

The Outreach at St. Thomas did a lot to help our brothers and sisters in need locally and around the globe in 2023. It only happens because many in our parish pitch in and help!

- 1) Re-establishing a committee: Under the leadership of Laurie Angelo and clergy liaison, Fr. Shane Carlson, we resumed regular meetings.
- 2) <u>Lenten Food Drive for Renewal Food Bank:</u>

Molly McConkey again ran this and as in years past it was a huge success as we watch the food accumulate under the altar. We donated many pounds of non-perishable food as well as hygiene items. Also, sorting food and checking for expiration dates made for a fun intergenerational activity on Palm Sunday!

- 3) Neighbor in Need Bags: Under the leadership of Larry Loranger this ministry.
  - Ziplock bags of toiletries, water bottle, handwarmers, clean cotton socks, and information about accessing Eastside services are assembled about every 4-5 months.
- 4) Cooking Lunch for Congregations for the Homeless (now PorchLight) Emergency Shelter: In April a Breaking Bread group gathered to cook a spaghetti lunch for 100



men at the old shelter on  $116^{th}$  St. in Bellevue. We had a lot of fun and the management and the men loved that we stayed and served. In May another

Breaking Bread group got together to make dinner for 21 people at the Sophia Way shelter. In December St. Thomas parishioners partnered with congregants from Temple de Hirsch Sinai-Bellevue to cook and serve another spaghetti lunch.




5) July Rotating Shelter: Under new leadership the congregation once again successfully carried out our July Rotating Shelter. Financial donations helped supply breakfast and lunch foods, toiletries, and cleaning and paper supplies. Dinners were lovingly prepared and donated by the congregation. We served on average 25 people per night for 32 nights, *a total of 800 dinners!* More importantly was the

hospitality and respect the men felt while they were here. Time and again they said the fact that so many people would come to eat and talk with them was healing since homelessness can degrade one's self-respect. Using previous years' donation targets we easily hit our goal of \$7,400 in June, but inventory and shopping volunteers did such a wonderful job we ended with a surplus that was returned to PorchLight. Also, the Men's Ministry participated by helping with evening setup, serving, and sharing meals with the men and a cadre of people made phone calls to our cooks which streamlined the entire effort.

- 6) Peace Fellowship (Formerly Friends of Palestine): The parish had a warm welcome for Fr. Fadi Diab, Rector of St. Andrew's Episcopal Church in Ramallah, his wife Ruba, and their son Andrew on Sunday 7/23. The diocesan Bishop's Committee for Justice and Peace in the Holy Land, Outreach Committee member Mary Pneuman has been a longtime member of this committee, sponsored their 2-week visitation. Fr. Fadi is a well-respected theologian in the Palestinian community and a prophetic voice for justice and peace and spoke on these topics when he was here.
- 7) **Vacation Bible Camp:** Kids can do awesome outreach projects!!! The camp kids made 40 no-sew fleece blankets for =^..^= awaiting adoption at the Seattle

Area Feline Rescue in shoreline. They also made 200 cookies and sandwiches for the men at the new Eastgate PorchLight (formerly CfH) Emergency Shelter. They also assembled 100 Neighbor in Need bags so quickly that the project has now been handed over to them to do in the future!



- 9) Fall Food for Renewal Food Bank and Cold Weather Coat Drive for the PorchLight Emergency Shelter: Once again St. Thomas stepped up to help our community by donating a lot of food just prior to Thanksgiving and warm coats as the temperatures started to dip. Youth on a Sunday evening gathering checked all the food for expiration dates and sorted the food, so Renewal did not have to do this.
- **10)The Christmas Giving Tree:** Under the leadership of Trish Evison St. Thomas donated many wonderful children's gifts to KidVantage and gift cards for Bellevue LifeSpring to donate to needy families.

The Building & Grounds Committee is tasked with assisting the Rector, Jr. Warden, Facilities





#### Recent Accomplishments:

We are a fairly new committee recently created to fill in the role of Greg Murray in the oversight of the building and grounds. In 2023, we completed over 25 projects to address maintenance issues ranging from fixing a leaking coffee maker, to stabilizing the pews in the sanctuary, to restoring and improving landscaping of our

facility. Some key accomplishments include:

- 1. Replacement and repair of the multiple electrical problems created by the ELC flood,
- 2. Improving the audio system in the Sanctuary,
- 3. Running a successful stained-glass window campaign with installment planned for early 2024,



#### Challenges During this Season of Rebuilding:

There are other projects targeted for 2024 to maintain our campus, which all required funding. Our biggest challenge is balancing the funding we have available against the cost of the backlog of projects. In some cases, we may need to delay projects to a future date when additional funding is available.

## St. Thomas Legacy Foundation

#### Description of Ministry:

The Legacy Foundation Committee is tasked with creating a marketing/information campaign to inform the parishioners about the Legacy Foundation, and to build the fund balance, which produces investment income that is used to finance church expenses.

The current balance is \$750,000, and we hope to grow the fund to \$2,500,000 within five years. This is accomplished by having parishioners place St. Thomas Church in their Will through other Estate Planning methods. Members can also give funds to the Church during their lifetime, which often creates a tax deductible.

#### Recent Accomplishments:

The committee was formed before COVID and was making progress to launch the Legacy program at that time. When COVID hit, all activities were put on hold.

The committee reformed in early 2023 and began producing marketing materials. The committee prepared a very professional brochure that will be emailed and mailed to the members in Spring 2024.



The committee also scheduled and held a "Get Your Ducks in a Row" (end of life planning) seminar, which met for two hours on five consecutive Tuesday evenings. The seminar was well attended and filled the library. The Legacy Foundation program was introduced at the last seminar session.

We are planning a marketing program to introduce and inform our members about the Legacy foundation. We are also preparing a list of parishioners for Mother Liz to call and visit to encourage donations and pledges to the Foundation.

A larger endowment balance would certainly help church finances and 2024 is the year to introduce and promote the Legacy Foundation.

#### Challenges During this Season of Rebuilding:



The most major challenge was to sift through enormous amounts of Legacy information, and present a concise, high level, professional brochure to introduce and describe the program. All the committee members worked hard on this project and Natalie Ingrisano did an outstanding job in producing the brochure in desktop publishing.

The next challenge will be forming a list of members for Mother Liz to visit, scheduling those visits, and securing donations and pledges to the Foundation. We

have been told by other churches that this is the most effective method of building the endowment balance.

## People Resources Committee

#### Accomplishments last year

- The church is fully staffed!
- Worked with Finance and Vestry after Stewardship Campaign to review wage/benefit budget and made recommendations for coming year.



#### Challenges

 Turnover in staff was challenging- re working job descriptions for new staff positions was necessary

We are looking forward to concentrating on staff wellness and appreciation in the coming year- ensuring that staff feel heard and appreciated during the many transitions and busy liturgical season!

#### **Finance Committee**

The Finance Committee is a standing committee of the Parish that is charged by the Vestry to provide oversight of the parish's financial plans, investments, an annual

financial review and other financial functions. Working with the Treasurer, the Finance Committee assists the Vestry in carrying out its fiduciary responsibilities by ensuring that good stewardship of all parish assets is practiced and that the financial resources are necessary to support the accomplishment of the Parish's mission and goals, both for the short and long-term are being actively built and preserved.



2) Sharing the Good, the Bad and the Ugly (Accomplishments & Challenges):

At the commencement of last year, the Finance Committee considered the 2023 Finance Plan of Missions (FPM) that we were recommending for approval to the Vestry, that at that time was labeled as a bold "faith budget" with the objective to propel the

Parish and our mission forward in a positive manner during a time of transition and change. This plan projected a \$358,607 operating deficit that revealed a monthly operating cost of \$122,353. The Finance Committee acknowledged that to take such a bold step will require us in faith, to prudently use a portion of our Operating Reserves to offset this proposed deficit. The Finance Committee that included five parishioners recommended that the Operating Reserves not be allowed to reduce below \$500,000 without a stringent review and careful regular planning.

Of interest and note, the Finance Committee and Vestry agreed to be prudent and thoughtful stewards with an eye towards growth and sustainability as we subsequently develop the FPM for 2024. At that time, the Finance Committee recommended that every effort be made to achieve a break-even budget by 2025.

With careful planning and a regular monthly review of our finances, we miraculously generated a small profit for 2023 with no reduction in our Operating Reserves.

During this time, we agreed to share our financial status to our parishioners in a transparent manner at the end of each quarter.

We engaged in a transition of clergy and staff that gradually meshed successfully with a great deal of support of common objectives from our parishioners. I would like to pay specific homage to Anne Bentley who spent countless hours with our new Parish Accountant, Jean Waite.

## Children, Youth, and Family Ministry

There were many wonderful highlights of the past year in our children's ministry. For

example, on Ash Wednesday and Good Friday, Mother Liz and Lisalynn Reed initiated new family-friendly services designed to engage children more fully in these liturgies. As part of our Godly Play program, we were able to purchase new stories

featuring saints of color from the Communion of Saints. In August, we hosted a very successful Vacation Bible camp for the first time since the pandemic, with many members of all ages volunteering. In the fall, Godly Play kicked off, backpacks were blessed, children baked dog cookies for our St. Francis Day pet blessing, participated in making our All Saints' Sunday altar, and enjoyed a fun and spooky Halloween Party. In December, there was Advent wreath making, the St. Nicholas breakfast, as well as our "Advent at home" Advent wreath lighting evenings on Zoom. In the fall, Fr. Edmund initiated a Sunday school class for middle schoolers that meets on Sundays at 9 a.m. to read and discuss *The Path*.




during this season of change and possibility, and eager to continue supporting and growing our strong programs.


